1.0	<b>Minutes / Matters Arising</b>	
1.1	The minutes of the April meeting were approved and seconded by Michelle McCallum and Christine Bell.	
1.2	Jean Weir agreed to take the minutes for the next two meetings and suggested that the minute taking be done on a rotational basis. It was agreed by the group that this was a good idea.

2.0	<b>Treasurer's Report</b>	
	CB reported that two very successful funding applications have resulted in a balance of £8577.36. CGI is grateful for the Earlsburn Funding of £4748.40 for the NLN and the 2011 Calendar and CVS Funding of £2869.00 for Publicity and Equipment. The Chair expressed his appreciation of all the work involved in securing the funding.	
3.0	<b>CTRA Heritage Beautification Project</b>	
3.1	Roy Bogle (Chair of CTRA) outlined a proposal for Trees for Gala Park in addition to the initial proposal for Dunipace Heritage Garden and Milton Row trees. He was seeking endorsement for the proposals from CGI. A discussion followed about the proposals. Varying views were expressed about the proposal for the Trees for Gala Park. It was felt that further consultation would be required with regard to changes in the Gala Park.	
3.2	CGI was happy to endorse the proposal for the Heritage Garden and Milton Row Trees and it was agreed that a letter of endorsement for the initial proposal be sent to CTRA to support their FET funding application which is due in by 7 June.	MMcC & MMcI

6.0	<p><b>Media – Falkirk Herald</b>  CB &amp; MMcC had a productive meeting with the editor Colin Hume. As a local person he is very supportive of CGI initiatives, especially the proposed opening of the upgraded path.</p>	
7.0	<p><b>Media – New Leaf News</b>  It is hoped that the online version will be available 5 June and the print copy w/b 7 June. There are about 500 subscribers and the procedure for online distribution should be easier in the future. More people have volunteered to distribute the paper copy.</p>	MMcC et al

9.0	<p><b>HELIX Environment Group</b>  MMcI reported his concerns about the proposal for a hotel and the cutting down of trees. He still questions the consultation process.  CB was not sure about a hotel being part of the project and would check out the HELIX website.</p>	CB
10.0	<p><b>Possible Official Opening of Upgraded Path</b>  CGI is in favour of an official opening possibly in September.  JW is liaising with Bespoke Bikes and DHS on trying to get the input of young people in the planning of the event.  Suggestions for the opening include – Cycle proficiency, Bike Checks, BMX event, Treasure Hunt. Any suggestions gratefully received. It will be important to involve representation from all path users.  An idea of the date for completion would be helpful.</p>	CB,JWe
11.0	<p><b>Oral History DVD</b>  The DVD produced as part of the joint CGI / Heritage Group Oral History Project will be shown on 11 June at the Heritage Rooms 7.30pm</p>	
12.0	<p><b>Dog Fouling Task Force</b>  The plan to hold an event on 1 May at the Gala Park had been postponed due to the Denny Town Centre event on the same day. CGI and the local footballers are still very keen for this to go ahead. This will be on hold until the autumn when football will resume in the park.</p>	
13.0	<p><b>Scottish Kennel Club – Green Dog Walkers Promotion</b></p>	
13.1	<p>CB &amp; GS attended the event on Sun 23 May. It was a very good day and they were very well treated. There was a lot of support for the GDW project. It appears that Falkirk Council is way ahead of other authorities with regard to bags and bins.</p>

Thanks were expressed to all those who had helped with the event. 155 bags of litter and a few trucks full of fly tipping were removed.

A suggestion from that meeting was that CGI host a meeting of local businesses and schools in September to discuss measures for tackling litter issues. CGI would not be able to offer this due to other commitments. A suggestion was that a letter could be sent to businesses inviting them to a Forum in Spring 2011. 16.0	<b>Denny High School Update</b>	
16.1	The litter strategy group were surveying the school bin provision and making suggestions for improvements. There have been discussions about the PSE programme and there are plans to re-vamp lessons for S1 and S2 for next session. If anyone knows of any good resources, materials and ideas the school would welcome information about them. It is planned for S1 classes to do a litter pick throughout the session. The school newsletter will now be available on the school website and no longer sent to parents so saving paper. A new section on the website includes a link to the CGI website. The school would welcome any suggestions for improvements.
